# MINUTES SPECIAL MEETING Mars Hill Town Hall – Conference Room May 20, 2019 at 6:00 p.m.

The Town of Mars Hill Mayor and Board of Aldermen met in special session on Monday, May 20, 2019 at 8:30 a.m. in the Mars Hill Town Hall.

#### Call to Order

The meeting was called to order by Mayor John Chandler. Mayor Chandler welcomed those in attendance.

#### **PUBLIC HEARING – Petition Requesting Annexation**

The Mayor addressed the first item of business, that being the required public hearing regarding the petition requesting annexation received from Eden Rock Enterprises, LLC and owner Brandon Quinn for certain property located on Parkway View Drive, Mars Hill, NC. Mayor Chandler opened the public hearing to receive comment from the public concerning this voluntary annexation request. There being no comments by the public, the Mayor called for a motion to close the public hearing. Aldermen Jolley made a motion to close the public hearing and Alderman Zink seconded the motion. Upon a call for a vote on the motion by the Mayor, the motion was approved unanimously.

Alderman Zink then made a motion to approve "An Ordinance to Extend the Corporate Limits of the Town of Mars Hill, North Carolina" to annex the property located on Parkway View Drive as

requested by the subject petition from Eden Rock Enterprises, LLC and owner Brandon Quinn. Alderman Jolley seconded the motion. Upon a call for a vote on the motion by the Mayor, the motion was approved unanimously.

#### <u>Subdivision Review – EBH Homes/Clifton Hamlin – S.R. 16727</u>

Mayor Chandler then addressed to the next item being the proposed subdivision plan submitted by Clifton Hamlin and EBH Homes, LLC. This plan calls for a proposed thirteen (13) lot subdivision located on 20.54 acres off of S.R. 1627, Mars Hill. This location is outside the corporate town limit but within the extra-territorial jurisdiction. The Mars Hill Planning Board reviewed the proposed subdivision plan on May 9, 2019 and voted to recommend approval of same to the Town Board of Aldermen. Mr. Clifton Hamlin was present and offered general plans for the subdivision. Following discussion by the Board, Mayor Chandler called for a motion. Alderman Davis made a motion to approve the subdivision as presented. Alderman Jolley seconded the motion. Upon a call for a vote on the motion by the Mayor, the motion was approved unanimously.
