# MINUTES SPECIAL MEETING Mars Hill Town Hall – Conference Room June 27, 2024 at 5:00 p.m.

The Town of Mars Hill Mayor and Board of Aldermen met in special session on Thursday, June 27, 2024, at 5:00 p.m. in the Mars Hill Town Hall. The meeting was held in accordance with public notice given pursuant to N.C.G.S. 160A-71 and 143-318.12(b)(2), and announced to the public at the June 3, 2024, regular meeting. (Attachment A)

#### Call to Order

The meeting was called to order by Mayor John Chandler. Mayor Chandler welcomed those in attendance.

#### Approval of the Agenda

Mayor Chandler then asked the Board to review the proposed agenda for approval. Upon review of the agenda, Mayor Chandler called for a motion. Alderman Nicholas Honeycutt made a motion that the agenda be approved as presented. Alderman Bob Zink seconded the motion. Upon a call for a vote on the motion by the Mayor, the agenda was unanimously approved. (Attachment B)

#### Fiscal Year 2023-2024 Budget

#### ORDINANCE - Budget Amendment - FY 2023-2024 - FY 2024-04

Mayor Chandler then moved to consider proposed budget amendments to the current year budget. Town Manager Nathan Bennett presented a summary of proposed FY 2023-2024 Budget Ordinance Amendment – FY 2024-04. Mr. Bennett explained the amendment transfers previously approved funding for the Bailey Mountain – Smith Farm Project from the general fund balance to the capital project fund, appropriates grant funds received from the Outdoor Communities Program to complete the Bailey Mountain/Duck Greenway Feasibility Study, and appropriates additional funds for miscellaneous line items to maintain budget integrity. The amendment recognizes additional revenues received from local option sales tax and reallocation of funds from budget savings within other areas of the budget. Upon completion of discussion, Mayor Chandler called for a motion.

Alderman Honeycutt made a motion to approve "FY 2023-2024 Budget Ordinance Amendment – FY 2024-04," as presented. Alderman Stuart Jolley seconded the motion. Upon a call for a vote by the Mayor, the motion was approved unanimously. (Attachment C)

#### Fiscal Year 2024-2025 Budget

BUDGET ORDINANCE — Mayor Chandler then moved to consider adoption of the Town of Mars Hill Budget Ordinance for Fiscal Year 2024-2025. Mr. Bennett noted that the budget message and required public hearing on the budget occurred at the regular Board meeting on June 3, 2024. Mr. Bennett advised the Board that there has been very little new information received from the Madison County Tax Office concerning final real property valuations for the Town of Mars Hill. Mr. Bennett advised that the tax office provided an updated preliminary valuation yesterday, June 26, 2024, totaling \$209,671,029, but the tax office continued to caution the town to only use 90% of this value as no appeals, use valuations, or additional new construction, are included in this figure. The preliminary base value of \$188,703,926 (90% of that County preliminary value) is then calculated at the proposed collection rate of 97%. It is expected this rate will provide the general fund with an estimated total property tax revenue of \$883,800. Ultimately, property tax, combined with other general fund sources, including specific function revenue sources such as the Madison County fire tax levy for the Mars Hill Fire District and state Powell Bill funds for street maintenance, are anticipated to be received for general fund operations.

Mr. Bennett advised that the proposed general fund budget is set at \$3,152,895. The property tax rate is recommended to be maintained at the current rate of \$0.47 (forty-seven) cents per \$100 (one-hundred dollars) of valuation. This rate is based on the preliminary property revaluation tax base noted above as Madison County has not yet provided the final valuation for FY 2025.

Mr. Bennett then addressed the proposed water and sewer fund budget. The water and sewer fund is an enterprise function which is required by the State of North Carolina to be supported only by the revenue generated from the service provided. In keeping with established Town policy, management recommends a 2.5% increase in water and sewer usage fees. This increase is necessary to keep the water and sewer fund solvent while providing safe drinking water, processing wastewater, and making necessary capital improvements to the water and sewer system. The water and sewer fund anticipates total revenue from customer charges, fees, and miscellaneous sources. The proposed water and sewer fund budget is set at \$1,330,181.

Mr. Bennett recommended adoption of the budget ordinance at this time. He stated that management and the Board should revisit the tax rate when the final tax valuation scroll is received from the Madison County Tax Office in September to determine if any modification to the rate is justified at that time. Upon completion of discussion, Mayor Chandler called for a motion. Alderman Zink made a motion to adopt the "Town of Mars Hill Budget Ordinance for Fiscal Year 2024-2025," as presented by management. Alderman Jolley seconded the motion. Upon a call for a vote by the Mayor, the motion was approved unanimously. (Attachment D)

#### Other Budget-Related Discussion

#### FY 2023-2024 Tax Settlement

Mr. Bennett presented the tax settlement for FY 2023-2024 as prepared and submitted by Tax Collector Stephanie Payne. Property value for 2023 tax billing was \$173,146,936, resulting in a total levy of \$813,790.64. As of the date of this settlement, \$760,499.73 has been collected, leaving an outstanding balance of \$53,290.91, or 93% collected. The settlement included a description of collection measures taken and a list of those delinquent taxpayers. Upon completion of discussion, Mayor Chandler called for a motion. Alderman Zink made a motion to adopt the "Town of Mars Hill Annual Settlement of the Tax Collector to the Governing Board for Fiscal Year 2023-2024," as presented. Alderman Honeycutt seconded the motion. Upon a call for a vote by the Mayor, the motion was approved unanimously. (Attachment E)

#### Independence Day - Additional Holiday/July Meeting

Alderman Zink stated that given the additional work asked of the employees for the Independence Day festival on Thursday, July 4<sup>th</sup>, the official town holiday, he believes that the Town should grant the employees an additional holiday on Friday, July 5<sup>th</sup>. Upon completion of a brief discussion, Mayor Chandler called for a motion. **Alderman Zink made a motion to grant all Town employees an additional holiday on Friday, July 5, 2024, as discussed.** Alderman Larry Davis seconded the motion. Upon a call for a vote by the Mayor, the motion was approved unanimously.

Mayor Chandler then asked if the July 1st regular meeting was necessary given the completion of the budget process, and no other pertinient business for next weeks meeting. Mr. Bennett confirmed that a meeting in July was not necessary at this time and should a need arise for a Board meeting, the Mayor can call a special meeting. Upon completion of discussion on the matter, Mayor Chandler called for a motion. Alderman Zink made a motion to cancel the July 1, 2024, regular board meeting and return to the regular schedule at the first Monday in August 2024, as discussed. Alderman Honeycutt seconded the motion. Upon a call for a vote by the Mayor, the motion was approved unanimously.

#### Personnel – Fire Department

Mayor Chandler then recognized Fire Chief Nathan Waldrup to present a personnel request. Chief Waldrup advised the Board that the department has had a vacant firefighter position available for over a year. Chief Waldrup advised the Board that he has an excellent candidate for the position at this time and provided a summary of qualifications. Chief Waldrup recommended the Board authorize employment of Byron Burleson for the firefighter position effective immediately. Upon discussion by the Mayor and Board members, the consensus of the Board was to authorize the immediate employment of Bryon Burleson as firefighter with the fire department if Fire Chief and Town Manager satisfied with final interview process.

#### **National Night Out**

Mayor Chandler then recognized Police Chief Chad Wilson to present information concerning a National Night Out event for the Town of Mars Hill. Chief Wilson advised that National Night Out is a unique annual opportunity for towns to join forces with thousands of other communities across the country in promoting cooperative, police-community crime prevention efforts. Chief Wilson stated it is essential that all citizens of Mars Hill be aware of the importance of crime prevention programs and the impact their participation can have on reducing crime, drugs and violence through police-community partnerships, neighborhood safety, awareness and cooperation. This will be the first time the Town of Mars Hill has participated in this event. Mr. Bennett read a draft proclamation aloud which makes certain findings and proclaims August 2, 2024, as National Night Out in the Town of Mars Hill. The event will be celebrated with a community event in conjunction with the August First Friday event on College Street. The event will include police, fire, and other public safety vehicle equipment tours, kids games, and entertainment. Upon completion of discussion, Mayor Chandler called for a motion.

Alderman Zink made a motion to adopt the "PROCLAMATION – NATIONAL NIGHT OUT – 2024," specifically establishing Friday, August 2, 2024, as National Night Out in the Town of Mars Hill, as presented. Alderman Honeycutt seconded the motion. Upon a call for a vote by the Mayor, the motion was approved unanimously. (Attachment F)

#### Adjourn

There being no further business before the Board, Mayor Chandler called for a motion to adjourn. **Alderman Zink made a motion to adjourn.** Alderman Jolley seconded the motion. Upon a call for a vote on the motion by the Mayor, the motion to adjourn was unanimously approved.

**WHEREAS** this Budget Ordinance for Fiscal Year 2024-2025 for the Town of Mars Hill, North Carolina, has been prepared pursuant to the provisions of Chapter 159 of the North Carolina General Statutes.

**NOW, THEREFORE, BE IT ORDAINED** by the Mayor and Board of Aldermen for the Town of Mars Hill, North Carolina, meeting in open session on June 27, 2024, that this Budget Ordinance for Fiscal Year 2024-2025 be adopted as follows:

#### SECTION 1. GENERAL FUND AND POWELL BILL FUND

#### **SECTION 3. PURPOSE**

The appropriations made herein are for the maximum amounts necessary to provide the services and accomplish the purpose described. Each department head shall affect savings to the extent possible.

#### SECTION 3. FISCAL YEAR EFFECTIVE DATE

Appropriations made herein are effective for the Fiscal Year beginning July 1, 2024, and ending on June 30, 2025.

#### SECTION 4. AD VALOREM TAXES

An *ad valorem* tax rate of forty-seven cents (\$0.47) per one hundred dollars (\$100.00) of assessed valuation of taxable property is hereby levied as the official tax rate for the Town of Mars Hill for the fiscal year beginning July 1, 2024 and ending June 30, 2025. This rate is based upon the total property preliminary valuation of \$209,671,029 less ten percent (10%) for pending real property appeals and exclusions pursuant to information provided by the Madison County Tax Office subject to the county mass real property revaluation effective January 1, 2024. The FY 2025 property tax is estimated with a collection rate of 97.0%.

#### SECTION 5. FEE SCHEDULE AND WATER AND SEWER USAGE RATES

There is hereby established for Fiscal Year 2024-2025 a schedule of fees, penalties, and fines and is included as an attachment to this ordinance as Appendix A. In addition, there shall be implemented a 2.5% increase in water and sewer usage base rates consistent with established water operation policy.

#### **SECTION 6. BUDGET OFFICER**

Pursuant to N.C. General Statute 159-8, the Town is required to appoint a Budget Officer and the Town of Mars Hill Board of Aldermen has and hereby appoints the Town Manager to serve as Budget Officer.

#### SECTION 7. UTILIZATION OF BUDGET ORDINANCE

The Budget Ordinance shall be the basis for the financial plan for the Town of Mars Hill during the fiscal year. The Budget Officer shall administer the budget and maintain such records consistent with this ordinance and the appropriate statutes of the State of North Carolina. The Budget Officer/Town Manager is authorized to execute contracts or other documents for which this ordinance makes an appropriation.

The Budget Officer/Town Manager is authorized to transfer amounts between objects of expenditure within a department without limitation. The Budget Officer/Town Manager is further authorized to transfer from one appropriation to another appropriation within the same fund as contained herein provided any such transfers shall be reported to the Board at their next regularly scheduled meeting and such action be recorded in the meeting minutes.

#### **SECTION 8. DISTRIBUTION AND DOCUMENTATION**

Copies of this Budget Ordinance shall be provided to the Budget Officer, Town Manager, Town Clerk, and the Treasurer/Finance Officer to be kept on file by them for direction in the collection of revenues and disbursement of Town funds.

#### **SECTION 9. ADOPTION**

A motion was made by Alderman Zink\_that the Budget Ordinance for Fiscal Year 2024-2025 be ADOPTED as presented. A second was made by Alderman Jolley. Upon a vote on the motion, the Budget Ordinance for Fiscal Year 2024-2025 for the Town of Mars Hill was approved by the Mayor and Board of Alderman for the Town of Mars Hill, North Carolina.
