MINUTES REGULAR MEETING Mars Hill Town Hall – Conference Room June 6, 2022 at 6:00 p.m.

The Town of Mars Hill Mayor and Board of Aldermen met in regular session on Monday, June 6, 2022, at 6:00 p.m. in the Mars Hill Town Hall.

Call to Order

The meeting was called to order by Mayor John Chandler. Mayor Chandler welcomed those in attendance.

Approval of the Agenda

Mayor Chandler asked the Board to review the proposed agenda for approval. Upon review of the agenda, Mayor Chandler called for a motion. **Alderman Nicholas Honeycutt made a motion that the agenda be approved as presented**. Alderman Stuart Jolley seconded the motion. Upon a call for a vote on the motion by the Mayor, the agenda was approved unanimously. (Attachment A)

Approval of Minutes

Mayor Chandler then asked the Board to review the minutes of the regular meeting held on May 2, 2022. There being no modifications to the minutes, Alderman Larry Davis made a motion that the minutes for May 2, 2022, be approved as presented by management. Alderman Bob Zink seconded the motion. Upon a call for a vote on the motion by the Mayor, the minutes were approved unanimously.

Old Business

Mayor Chandler then moved to address old business.

<u>Request for Voluntary Annexation – 44 Roy Edwards Lane, Mars Hill – Maggie Howard, LLC PIN: 9757-02-9970 AND 9757-12-2807</u>

Mayor Chandler recognized Town Manager Nathan Bennett to review the petition request for voluntary annexation presented to the Board. Mr. Bennett advised that the Town received a petition dated April 13, 2022,

for voluntary contiguous annexation from the authorized representative of Maggie Howard, LLC for property containing two lots located at 44 Roy Edwards Lane, Mars Hill, and identified by Madison County Parcel Identification Numbers 9757-02-9970 AND 9757-12-2807. Mr. Bennett advised that the petition application includes a copy of the subject property deed, plat, and a map. Mr. Bennett advised that the required clerk investigation is complete and that the Clerk has provided the Certificate of Sufficiency. The staff investigation determined this property meets the criteria for voluntary annexation and Mr. Bennett recommended approval of the associated ordinance. Pursuant to previous Board direction given on May 2, 2022, the public hearing notice for this voluntary annexation petition was published as required by law in the Madison News-Record & Sentinel on May 25 and June 1, 2022. The next step is to hold the public hearing on the request for annexation.

<u>PUBLIC HEARING</u> – Mayor Chandler then convened the public hearing to receive comments from the general public concerning the request for voluntary annexation of the subject property located at 44 Roy Edwards Lane, Mars Hill, and identified by Madison County Parcel Identification Numbers 9757-02-9970 AND 9757-12-2807, pursuant to notice duly published to the public. There being no comments from the public, Mayor Chandler closed the public hearing.

ORDINANCE — Upon completing discussion of the matter, Mayor Chandler called for a motion. Alderman Honeycutt made a motion to approve "An Ordinance to Extend the Corporate Limits of the Town of Mars Hill" pursuant to the petition for voluntary annexation of the parcel identified as 44 Roy Edwards Lane (Madison County PIN: 9757-02-9970 AND 9757-12-2807 and Madison County Registry Deed Book 747 at Page 118) by the property owner of record, Maggie Howard, LLC, through and by its' agent of record Suzetta B. Wolfe, as more fully set forth in the petition application. Alderman Davis seconded the motion. Upon a call for a vote by the Mayor, the motion was approved unanimously. (Attachment B)

New Business

Mayor Chandler then moved to address new business.

PRESENTATION - Bailey Mountain Preserve and Park Improvements - Park Master Plan

Mayor Chandler then recognized Mr. Dan Greenberg with WithersRavenel Engineers, retained by the Town to complete the park master plan, to provide information regarding the Bailey Mountain Preserve and Smith Farm Park Master Plan. Mr. Greenberg provided the Board with copies of the draft plan and described the thorough process that was undertaken by the engineers to develop this masterplan that will be used to guide the construction of various improvements on the farm portion of the property utilizing grant funds received from the N.C. Parks and Recreation Trust Fund. The engineers met with stakeholders including the Hoffman Foundation, Appalachian Barn Alliance, the Town Parks and Recreation Committee, and town staff both onsite at the park and in office and though virtual meetings to gain insight into expectations for the final plan. Three conceptional options were developed culminating in the proposed final plan. The concepts included the following: new 36' square barn site nestled with the existing barns, accessible concrete sidewalk to barn area, stone screening walkway among barns, stage and amphitheater seating for 50 people at existing barns, accessible route to the Discovery Center, accessible stone screening walkway to Banjo Branch, mown path around hillside, picnic pavilions/picnic tables on slope and near barns, parking and driveway improvements, and restrooms. Implementation of the plan would be a phased approach to begin with the elements included in the N.C. Parks and Recreation Trust Fund grant and the local matching dollars that have been secured to date. Other items identified in the plan would be implemented as funding sources are identified. The Board expressed appreciation for the hard work done by the team and partners to develop this plan and the Board, by consensus, approved the plan as presented.

RESOLUTION - Trail Naming - Richard L. Hoffman Trail

Mayor Chandler then recognized Mr. Bennett to provide an overview of the resolution pertaining to the naming of the main trail at the Smith Farm in honor of Richard L. Hoffman. Mr. Bennett recognized members of the Hoffman family in attendance, Mrs. Jeanne Hoffman and Mr. Lee Hoffman. Mr. Bennett read the resolution into the record recognizing Mr. Richard L. Hoffman and the Richard L. Hoffman Foundation. The Foundation has been instrumental in the preservation of lands in and around the Town of Mars Hill, most notably those around Bailey Mountain, including those now known as the Bailey Mountain Preserve and Park. The resolution designates the main hiking trail from the park entrance on Forest Street traversing the mountainside to the summit of Bailey Mountain as "The Richard L. Hoffman Trail." Mr. Bennett and Mr. Ryan Bell, chair of the Town Parks and Recreation Committee, advised the Board that the Parks and Recreation Committee approved a motion to recommend approval of this naming designation to the Board at their last meeting. The resolution is incorporated as a part of these minutes. Upon completion of discussion of the resolution and hearing comments from Board members to the family thanking them for their efforts, and upon hearing brief comments from Mrs. Jeanne Hoffman and Mr. Lee Hoffman, Mayor Chandler called for a motion. Alderman Jolley made a motion to approve the resolution entitled, "RESOLUTION - NAMING OF THE MAIN TRAIL AT BAILEY MOUNTAIN PRESERVE AND PARK THE RICHARD L. HOFFMAN TRAIL" as presented. Alderman Zink seconded the motion. Upon a call for a vote by the Mayor, the motion was approved unanimously. (Attachment C)

PRESENTATION - Madison County Arts Council - Madison County Arts Center

Mayor Chandler then recognized Ms. Laura Boosinger, executive director of the Madison County Arts Council, to provide a presentation on the activities of the Arts Council and their Arts Center project. Ms. Boosinger was accompanied by Rob Pulleyn, Project Campaign Chair. Ms. Boosinger discussed the many programs provided by the Council to the community. These programs include the WART-FM community radio station, traditional and modern art and craft exhibits, arts in education, festivals, concerts, and performances, etc. Ms. Boosinger and Mr. Pulleyn also provided an overview of the historic building the Council has acquired in Marshall that will serve as the Madison County Arts Center. The organization currently occupies a portion of the space on Main Street, but a capital fundraising campaign is underway fully renovate the space and provide a location totally dedicated to the arts in Madison County. More information regarding the Madison County Arts Council and the Arts Center project is available on their website, Madisoncountyarts.com. The Mayor and Board members thanked them for their presentation and for the work they are doing for the Madison County community.

Fiscal Year 2022-2023 Budget

BUDGET MESSAGE — Mayor Chandler then recognized Town Manager Nathan Bennett for a presentation of the proposed FY 2022-2023 Fiscal Year Budget and delivery of the Budget Message. Mr. Bennett provided a summary of the components of the budget to guide operations and initiatives of the Town of Mars Hill for the fiscal year beginning July 1, 2022, through June 30, 2023. Mr. Bennett advised that the proposed general fund budget is set at \$2,744,497. This proposed budget does reflect an overall increase from the current year of approximately \$554,197, primarily due to programming federal coronavirus relief-related funds such as the American Rescue Plan Act. The property tax rate is recommended to be maintained at the current rate of \$0.47 (forty-seven) cents per \$100 (one-hundred dollars) of valuation. This rate is based on the expected valuation of the property tax base of \$144,904,897 as provided by the Madison County Tax Department with a 6% increase factor as the County has not yet provided the final valuation for FY 2023. With a collection rate of 95%, it is expected this rate will provide the general fund an estimated total property tax revenue of \$685,820. Ultimately, property tax, combined with other general fund sources, including specific function revenue sources such as the

Madison County fire tax levy for the Mars Hill Fire District and state Powell Bill funds for street maintenance, are anticipated to be received for general fund operations.

The water and sewer fund is an enterprise function which is required by the State of North Carolina to be supported only by the revenue generated from the service provided. In keeping with established Town policy, management recommends a 2.5% increase to water and sewer usage fees. This increase is necessary to keep the water and sewer fund solvent while providing safe drinking water, processing wastewater, and making necessary capital improvements to the water and sewer system. Water user fees have returned to pre-COVID-19 level and taken together with increased residential development, the system is financially strong. Town staff will continue to analyze operations for expected usage and will be prepared to make corrective recommendations as appropriate. The water and sewer fund anticipates total revenue from customer charges, fees, and miscellaneous sources totaling \$1,164,300. Mr. Bennett advised that the proposed water and sewer fund budget is set at \$1,164,300.

Expenditures are proposed to be set at or near current year levels in most areas of operation. Management recommends a \$2.00 per hour salary hourly rate increase across-the-board for all permanent FT/PT staff. This commitment to the Town workforce is to show appreciation for the hard work through the COVID-19 pandemic, as well as to allow the Town to retain and recruit necessary employees in a very competitive job market. Funding is recommended to provide an additional three (3) full-time firefighters/EMT personnel and associated benefit costs to assist with increasing and overlapping call volumes. Management also plans to work with the police department to convert command staff to salaried positions from hourly rates, together with funding for replacement of a patrol vehicle, additional training and equipment. Mr. Bennett advised that copies of the budget message and budget ordinance will be available in the administration office in Town Hall and also on the Town website.

The FY 2022-2023 Budget Message is incorporated by reference to these minutes as Attachment D. (Attachment D)

<u>PUBLIC HEARING</u> – Mayor Chandler thanked Mr. Bennett for his work on the budget and for the presentation. Mayor Chandler then opened the floor to members of the public present for the public hearing on the proposed budget for FY 2022-2023. Lee Hoffman made brief comments regarding the budget and the work the Town does to provide the best resources and services to the Town. There being no additional comments from the members of the general public, Mayor Chandler closed the public hearing.

<u>BUDGET ORDINANCE</u> – Mayor Chandler then moved to consider adoption of the Town of Mars Hill Budget Ordinance for Fiscal Year 2022-2023. Upon completion of discussion, Mayor Chandler called for a motion. **Alderman Jolley made a motion to adopt "Town of Mars Hill Budget Ordinance for Fiscal Year 2022-2023," as presented.** Alderman Honeycutt seconded the motion. Upon a call for a vote by the Mayor, the motion was approved unanimously. (Attachment E)

FY 2021-2022 Budget Amendments

Mayor Chandler then moved to consider proposed budget amendments to the current year budget. Mr. Bennett presented a summary of the proposed FY 2021-2022 Budget Ordinance Amendments – FY 2022-04 and 2022-05. Mr. Bennett explained that these amendments add additional appropriations to a number of departments to address expenditures related to supplies and equipment, as well as other equipment maintenance and services, that were unexpected at the time of original budget adoption. The amendment also allocates additional revenue received from sales tax collections and state grants. Upon completion of discussion, Mayor Chandler called for a

motion. Alderman Honeycutt made a motion to approve the "FY 2021-2022 Budget Ordinance Amendments – FY 2022-04 and FY 2022-05" as presented. Alderman Davis seconded the motion. Upon a call for a vote by the Mayor, the motion was approved unanimously. (Attachments F and G respectively)

Town Manager Report - Nathan Bennett, Town Manager

Mayor Chandler then recognized Mr. Bennett to provide the Town Manager Report.

COVID-19 Response

Mr. Bennett provided the Board an update on the continuing Town response to the coronavirus and COVID-19 situation. The Town continues to be under the state and locally designated state of emergency in response to COVID-19. Mr. Bennett advised there have been no issues to note due to COVID with Town operations since the last Board meeting.

<u>CONTRACT – Gould Killian Audit Services Contract for FY 2022</u>

Mr. Bennett provided the Board information concerning the Gould Killian Audit Services Contract for FY 2022. This contract is required to meet requirements of the N.C. Local Government Commission and to set the requirements and expectations between the Town and the audit firm contracted by the Town to audit activities completed during the FY 2022 budget year. Upon completion of discussion, Mayor Chandler called for a motion. Alderman Zink made a motion to approve the "Agreement to Provide Services AND Contract to Audit Accounts" by Gould Killian CPA Group, P.A. for Fiscal Year 2021-2022 as presented. Alderman Honeycutt seconded the motion. Upon a call for a vote by the Mayor, the motion was approved unanimously.

RESOLUTION - Support for AdventHealth Proposal for Acute Care Hospital

Mr. Bennett advised the Board that AdventHealth is petitioning the State of North Carolina to construct a new acute care hospital in western North Carolina, specifically in the Madison, Buncombe, Yancey, and Graham county service area. This hospital as proposed would be a 67-bed facility and provide a number of services to the community. Mr. Bennett advised the Board this effort to expand access to healthcare facilities for the citizens of Mars Hill and the region is desperately needed in this under-served area. Mr. Bennett read the prepared resolution of support concerning the development of a new hospital by AdventHealth. The resolution is incorporated by reference into these minutes. Upon completion of discussion, Mayor Chandler called for a motion. Alderman Zink made a motion to approve the "RESOLUTION – IN SUPPORT OF ADVENTHEALTH FOR DEVELOPMENT OF A NEW HOSPITAL IN WESTERN NORTH CAROLINA," as presented. Alderman Jolley seconded the motion. Upon a call for a vote by the Mayor, the motion was approved unanimously. (Attachment H)

July Meeting Date

Mr. Bennett advised the Board that the regular meeting date for July coincides with the Independence Day holiday on July 4, 2022. Mr. Bennett advised that upon completion of the business on this agenda, that he does not expect a pressing need for a July meeting. Upon completion of discussion, Mayor Chandler called for a motion. Alderman Zink made a motion to cancel the July 4, 2022, regular meeting and resume the regular meeting schedule with the August 1, 2022 meeting. Alderman Davis seconded the motion. Upon a call for a vote by the Mayor, the motion was approved unanimously.

General Update

Mr. Bennett provided the Board with a general update of Town operations and other items of interest to the Board.

Public Comment

Mayor Chandler then moved to public comment. Mayor Chandler recognized Mr. Ryan Bell. Mr. Bell thanked the Board for their approval of the recognition of the Richard L. Hoffman Foundation and the naming of the trail at the Bailey Mountain Preserve and Park in his honor. Mr. Bell advised that the "Trail Geezers," have completed the final segment of the trail to the summit of Bailey Mountain and that a there will be a ceremony and community hike in recognition of this accomplishment on Saturday, July 2, 2022, at 10 a.m. and he invited the Board to attend.

There being no further public comments, Mayor Chandler moved to the next agenda item.

Closed Session (Pursuant to N.C.G.S. 143-318.11)

There was no Closed Session.

AN ORDINANCE TO EXTEND THE CORPORATE LIMITS OF THE TOWN OF MARS HILL, NORTH CAROLINA

WHEREAS, the Board of Aldermen has been petitioned under G.S. 160A-31, as amended, to annex the area described herein; and

WHEREAS, the Board of Aldermen has by resolution directed the Town Clerk to investigate the sufficiency of said petition; and

WHEREAS, the Town Clerk has certified the sufficiency of said petition and a public hearing on the question of this annexation was held at the <u>Mars Hill Town Hall</u> at <u>6:00</u> o'clock, <u>p.m.</u> on the <u>6th</u> day of <u>June</u>, 20<u>22</u> after due notice by publication on the <u>25th</u> day of <u>May</u>, 20<u>22</u>; and

NOW, THEREFORE, BE IT ORDAINED by the Board of Aldermen of the Town of Mars Hill, North Carolina:

Section 1. By virtue of the authority granted by G.S. 160A-31, as amended, the following described territory, is hereby annexed and made part of the Town of Mars Hill as of the __6th__ day of __June___, 2022.

(Insert Metes and Bounds Description)

That real property located at 44 Roy Edwards Lane, Mars Hill owned by Maggie Howard, LLC, as set forth and more fully described in Deed Book 747 at Page 118 and Plat Book 9 at Page 738 in the Madison County Registry, Office of the Register of Deeds of Madison County, North Carolina, and further identified by Madison County Property Identification Number 9757-02-9970 (Lot 1) and PIN 9757-12-2808 (Lot 2) and the attached Exhibit 1.

Section 2. Upon and after the 6th day of June, 2022, the above described territory and its citizens and property shall be subject to all debts, laws, ordinances, and regulations in force in the Town of Mars Hill and shall be entitled to the same privileges and benefits as other parts of the Town of Mars Hill. Said territory shall be subject to municipal taxes according to G.S. 160A-58.10.

Section 3. 

FISCAL YEAR 2022-2023

To the Town of Mars Hill Mayor and Board of Aldermen and Citizens of the Town of Mars Hill:

In accordance with North Carolina General Statute 159-11, the Town of Mars Hill Fiscal Year 2022-2023 proposed budget is respectfully submitted for your review and consideration. The proposed budget sets forth a plan of operations for all Town departments, programs, and initiatives for the coming year. This proposed budget is balanced in accordance with the Local Government Budget and Fiscal Control Act with General Fund revenues and expenditures each totaling \$2,744,497. The Water and Sewer Fund is balanced with revenues and expenditures each totaling \$1,164,300.

INTRODUCTION

This budget message will introduce the Town of Mars Hill Fiscal Year 2022-2023 proposed budget. The budgeting process begins in early spring with management requesting proposed appropriation use plans from departments, agencies, and other Town-supported entities. Management takes those requests and develops a balanced budget in line with expected revenue from numerous sources. This document will provide a summary of how the Town plans to utilize its fiscal resources and will highlight significant impacts to the Town's budget. I am pleased to present this budget that provides the tools and resources necessary for an effective and efficient government for the Citizens of the Town of Mars Hill.

REVENUES

It is the priority of elected officials and management to operate Town government in a professional, efficient, business-like manner. This budget provides a priority spending plan that attempts to minimize the tax burden on the Town taxpayer. The Town's primary general fund sources of revenue are property, sales, and utility franchise taxes. Over the past two years, the Town has managed to provide all services and operations uninterrupted by the COVID-19 pandemic. Town revenue was impacted by the long-term closures of significant water consumers such as Mars Hill University and Mars Hill Elementary School. Those entities have returned to normal operations and likewise those revenue trends have also returned to pre-COVID levels over the current fiscal year. Surprisingly, despite economist projections to the contrary at the onset of the pandemic, sales and property tax revenue were not negatively affected as predicted, and in fact sales taxes have seen significant growth over the past two years. It does, however, remain to be seen if this is a permanent situation. Currently, the economy for the country and our local community is suffering from unprecedented inflation and sky-rocketing gas prices. Those conditions are reflected in this budget in terms of increased material and fuel costs, and we forecast this condition to last well into calendar year 2023. The bright news is the country and local area are in the midst of recovery, both in terms of the COVID-19 illness and economically despite the issue with inflation, with new confidence that the worst of the pandemic may be over. Wages are increasing in both the private and public sectors with a plentiful job market.

Regarding property taxes for Fiscal Year 2022-2023, management recommends no change to the current property tax rate at this time. The property tax rate is recommended to be maintained at the current rate of \$0.47

(forty-seven) cents per \$100 (one-hundred dollars) of valuation. This rate is based on the expected valuation of the property tax base of \$144,904,897 as provided by the Madison County Tax Department with a 6% increase factor as the County has not yet provided the final valuation for FY 2023. With a collection rate of 95%, it is expected this rate will provide the general fund an estimated total property tax revenue of \$685,820. Ultimately, property tax combined with other general fund sources, including specific function revenue sources such as the Madison County fire tax levy for the Mars Hill Fire District and state Powell Bill funds for street maintenance, are anticipated to total \$2,744,497.

The water and sewer fund is an enterprise function which is required by the State of North Carolina to be supported only by the revenue generated from the service provided. In keeping with established Town policy, management recommends a 2.5% increase to water and sewer usage fees. This increase is necessary to keep the water and sewer fund solvent while providing safe drinking water, processing wastewater, and making necessary capital improvements to the water and sewer system. As stated previously, water user fees have returned to pre-COVID-19 level and taken together with increased residential development, the system is financially strong. Town staff will continue to analyze operations for the expected usage and will be prepared to make corrective recommendations as appropriate. The Water and Sewer Fund anticipates total revenue from customer charges, fees, and miscellaneous sources totaling \$1,164,300.

EXPENDITURES AND INITIATIVES

The Town of Mars Hill is dedicated to sound fiscal management, capital planning and responsible day-to-day operations. Accurate budget projections and a disciplined approach to budget administration have allowed the Town to successfully maintain essential public services, enhance public safety, make strategic investments to support community and economic development while maintaining financial stability. This budget is a comprehensive document that addresses the fiscal needs of some 12 departments and affiliated agencies. The intention of this section is to highlight some of the larger appropriations for departments and key initiatives included budget. In this era of economic uncertainty due to the continued effects of the COVID-19 pandemic, management recommends limited new capital investments but concentrating financial resources on necessary public safety enhancements and completion of important water and wastewater infrastructure initiatives.

- 1. <u>Fire Department</u>: The Mars Hill Fire Department is a Town department that also serves county residents in the surrounding Mars Hill Fire District. The Department has a small full and part-time paid staff with 30 volunteers. It is vital that the Department has the equipment and resources needed to respond to any emergency whether it be a manmade or natural disaster. There is funding in this budget for increased personnel costs, including health insurance and retirement contributions mandated by the N.C. State Health Plan and Local Government Retirement System respectively, for the current five (5) full-time employees. In addition, due to increased call volumes throughout the town and district with a high percentage of overlapping calls that is, more than one call occurring simultaneously this proposed budget includes funding for employment of an additional three (3) full-time firefighters/EMTs and the associated personnel costs for onboarding. There is also funding recommended for capital equipment as needs may warrant. The total fire department budget is recommended for an appropriation of \$747,563 utilizing the revenue from the fire tax district and additional town funds.
- 2. <u>Police Department</u>: The Town is committed to providing our citizens and visitors with a professional police force to ensure the safety and security of our community. Mars Hill is fortunate to have a very low crime rate, but this positive statistic is due in large part to the great community policing activities provided by our police officers. An additional full-time officer position was added in the FY 20-21 budget and that position was filled and has been beneficial in providing enhanced coverage throughout the Town. Continued costs

associated with implementation of the new position, accompanied by increased personnel costs for health insurance, retirement contributions, and supplemental retirement expenses, result in a modest increase to the proposed budget for the department. As part of the ongoing restructuring of police department personnel, funding is included to convert police command staff to salaried positions from the current hourly rate arrangement. This transition will accomplish several goals including: allowing an officer to serve in a detective role, allow scheduling of a "mid-shift" providing two patrol officers during the high call volume period, and, ultimately, reduce overtime costs. Additional funds are included for the acquisition of a replacement patrol vehicle using funds originally budgeted in the current year but unspent, together with additional appropriations in this proposed budget. There are also funds provided for other needed equipment upgrades and training. The total police department budget is recommended for an appropriation of \$620,200.

- 3. Water and Sewer System: The Town recently received approximately \$350,000 in federal Appalachian Regional Commission funds and an additional \$350,000 matching grant from the Dogwood Health Trust to install 1,200 LF of new sewer line and 2,200 LF of new water line from the new sewer pump station at I-26 Exit 11 southward along Calvin Edney Road to assist in future economic development. In addition, the Town will receive American Recue Plan Act funds, of which approximately \$350,000 will be used to replace an aging sewer pump station and rehabilitate an associated second station serving the Woodhaven/South Main Street service area. This project is currently in the design phase and is expected to proceed to bid in August 2022, with construction to begin as soon as possible thereafter. Another project includes the maintenance and rehabilitation of water tanks at the Town's water treatment plant. This project is approximately \$40,000 and will be completed in late 2022. This proposed budget recognizes a return of normal water consumption by large uses as well as continued residential development projects. The proposed budget makes allocations for necessary improvements and replacement of certain water lines and meters to improve efficiencies system-wide as appropriate within the funds available as well as the purchase of mowing equipment to maintain the water treatment plant grounds.
- 4. <u>Bailey Mountain Preserve and Park.</u> In the Fall of 2021, the Town received a N.C. Parks and Recreation Trust Fund grant award for \$268,536. This grant, together with additional local funds and other grant funds, will be used to provide a number of recreational amenities at the park located on Forest Street, which serves as the public gateway entrance to the iconic Bailey Mountain and a host of hiking trails both on Town property and the adjoining Bailey Preserve owned by the Richard L. Hoffman Foundation. The first phase of construction will provide restroom facilities, parking enhancements, accessible walking trails, mountainous hiking trials, picnic shelters, a nature/discovery center, amphitheater, and improvements to the barns located on the property for use as meeting and event spaces. This project is nearing completion of the park master planning stage, with construction documents and bidding to proceed in early August 2022. This budget includes funds to begin the project and move forward with planning, permitting, and construction.
- 5. *Employee Compensation*: Town employees work hard to provide a safe, secure, healthy, and prosperous community. To keep good employees in all sectors of Town employment, particularly in the current highly competitive job market, compensation commensurate with the knowledge and skills in consideration of the current labor market and economic circumstances is necessary. This budget recommends an across-the-board pay increase of \$2.00 per hour for all permanent full-time and part-time employees. This payrate increase brings all staff at or above \$17.00 per hour and represents an average overall pay increase of 9.25%. In addition to compensation, the N.C. Local Government Retirement System has increased the employer (Town) contribution rate an additional 0.75% (to 12.1%) for all general employees and 1.0% (to 13.1%) for law enforcement officers who are members of the system requiring a significant additional contribution from the Town. The N.C. State Health Plan has not released rates for the next enrollment period effective January 1,

2023, however, an anticipated increase of 5% in those rates has been included in this budget. Any other increases will be considered through the budget amendment process.

BUDGET SUMMARY

The leadership of the Mayor and Board of Aldermen together with the diligent work of Town employees, has resulted in a financially stable, effective, and efficient Town government. This has allowed the Town of Mars Hill to undertake a number of capital projects for the long-term improvement of our community while at the same time providing excellent day-to-day services our citizens deserve. The goal of this proposed budget is to provide the financial resources to continue the excellent work that all departments, agencies, and community partners do to move the Town of Mars Hill forward.

SECTION 3. PURPOSE

The appropriations made herein are for the maximum amounts necessary to provide the services and accomplish the purpose described. Each department head shall affect savings to the extent possible.

SECTION 3. FISCAL YEAR EFFECTIVE DATE

Appropriations made herein are effective for the Fiscal Year beginning July 1, 2022 and ending on June 30, 2023.

SECTION 4. AD VALOREM TAXES

An *ad valorem* tax rate of forty-seven cents (\$0.47) per one hundred dollars (\$100.00) of assessed valuation of taxable property is hereby levied as the official tax rate for the Town of Mars Hill for the fiscal year beginning July 1, 2022 and ending June 30, 2023. This rate is based upon the total FY 2022 property valuation of \$144,904,897.00 with and an increase factor of 6% as the Madison County Tax Office has not provided new property valuation estimate. The preliminary FY 2023 property valuation is then estimated with collection rate of 95.0%.

SECTION 5. FEE SCHEDULE

There is hereby established for Fiscal Year 2022-2023 a schedule of fees, penalties, and fines and is included as an attachment to this ordinance as Appendix A. In addition, there shall be implemented a 2.5% increase in water and sewer usage base rates consistent with established water operation policy.

SECTION 6. BUDGET OFFICER

Pursuant to N.C. General Statute 159-8, the Town is required to appoint a Budget Officer and the Town of Mars Hill Board of Aldermen has and hereby appoints the Town Manager to serve as Budget Officer.

SECTION 7. UTILIZATION OF BUDGET ORDINANCE

The Budget Ordinance shall be the basis for the financial plan for the Town of Mars Hill during the fiscal year. The Budget Officer shall administer the budget and maintain such records consistent with this ordinance and the appropriate statutes of the State of North Carolina. The Budget Officer/Town Manager is further authorized to execute contracts or other documents for which this ordinance makes an appropriation.

SECTION 8. DISTRIBUTION AND DOCUMENTATION

Copies of this Budget Ordinance shall be provided to the Budget Officer, Town Manager, Town Clerk, and the Finance Officer to be kept on file by them for direction in the collection of revenues and disbursement of Town funds.
