#### PARADE RULES AND GUIDELINES

- 1. **SAFETY is our primary concern**. Please help us reduce risk by being observant of your surroundings, particularly children, along the parade route. Participants must have lights or sufficient reflective clothing.
- 2. Entries must pertain to the holiday season.
- 3. No Santa's or Mrs. Claus. Parade participants dressed like Santa or Mrs. Claus will be removed from the parade by parade staff. (There is only one Santa and he has his own entry.)
- 4. Candy may be distributed. If thrown from a vehicle, please toss candy from the side of vehicles toward the sidewalk area and not at individuals. Do not throw objects toward the front of vehicle.
- 5. Arrive at the staging area with your entry/float/vehicle no later than 5:00 p.m. to avoid congestion.
- 6. NO RIDING HORSES ALLOWED IN THIS PARADE DUE TO NIGHTTIME HAZARDS.
- 7. Entries with other approved animals must provide their own clean-up during the line-up and along the parade route. Also, for the safety of spectators and parade participants, all animals must be accompanied by a chaperone.
- 8. NO DRIVERS UNDER THE AGE OF 18.
- 9. Drivers must watch for children and yield to pedestrians.
- 10. Drivers must minimize the gap between the entrants. Don't crowd them but stay close and keep the parade moving.
- 11. NO OPEN WHEEL TRAILERS. All trailer floats must have fenders that cover the wheels.
- 12. No alcohol or tobacco use allowed.
- 13. **Cancellation Policy:** In the event of a severe weather cancellation, information will be announced via the Town of Mars Hill Social media accounts on Twitter and Facebook, local radio and TV stations. Should a cancellation be necessary, the parade <u>will not</u> be rescheduled.

#### PARADE ROUTE:

LINE UP WILL BE AT MARS HILL ELEMENTARY SCHOOL FOR FLOATS AND AT TOWN HALL FOR WALKERS. THE PARADE BEGINS AT N. MAIN AND BRUCE ROAD AND PROCEED TO RIGHT TURN ONTO CASCADE STREET (NC 213) TO RIGHT TURN ONTO ATHLETIC STREET TO TERMINATE. VEHICILES MUST RETURN TO THE ELEMENTARY SCHOOL TO UNLOAD AND DISBAND TO AVOID TRAFFIC CONGESTION ON NC 213.
